Regulations for Using the Computing Facilities

BY USING THE COMPUTING FACILITIES OF THE DEPARTMENT, THE USER IS CONFIRMING THE ACCEPTANCE OF THESE REGULATIONS AND SUPPLEMENT(*), AND ARGEEING TO BECOME BOUND BY THESE REGULATIONS AND SUPPLEMENT(*).

Definitions

"The Department" means Department of Computer Science and Engineering, the Chinese University of Hong Kong, Shatin, Hong Kong.
 "Computing facilities" means all facilities in the Department.

Use of your computing facilities is a privilege to be exercised responsibly. Ignorance is not an excuse. Therefore, study the regulations carefully.

- A user must not allow any other to access the resources granted to him/her. Therefore a user must not disclose his/her
 computer account password to any other person, or allow account accessed by unauthorized persons using any trusting method
 under any circumstances. E.g. ".rhosts" in Unix.
- A user must not use computing resources or access information to which he/she has not been granted access by the
 Department. A user shall not access other sites' computing resources without approval from the sites' authority.
- A user must never attempt to intrude the computer systems of local or external sites, or obtain illegal access to another account of local or external sites.
- 4. A user must not use the computing facilities to engage in activities leading to commercial gain, monetary or otherwise.
- 5. A user must never attempt to cause any damage to the computing facilities and is responsible for the cost of repair or replacement.
- 6. A user must never attempt to change the configuration of the workstations or the PCs without consent of the computing staff.
- A user shall not interfere with other users.
- 8. A user shall not copy proprietary/licensed software owned by the Department.
- A user shall wear his/her user ID card in the laboratories.
- A user shall not turn off any Unix workstation in any circumstance.
- A user shall not store any materials with offensive content in his/her computer account and /public in Unix workstations, or any materials that infringe the laws regarding Copyright, Patent and Trademark.
- 12. A user shall not abuse the computing resources.
- 13. No food or beverage are allowed in the laboratories.

A user shall report cases concerning violation of laboratory regulation to the computing staff. It may be necessary for the computing staff in the Department to access your account without your knowledge to investigate suspected abuse. Since it can be impossible to distinguish a legitimate project from potential abuse, you may be asked to come forward to explain your actions.

User who violates any of the regulations shall be disciplined in accordance with the nature and gravity of the offence. According to University Regulations, such disciplinary action may take the form of any of the following penalties:

- reprimand
- suspension from part or all of the privileges of using the computing resources for a specified period of time;
- demeri
- suspension from the University for a specified period of time; or
- termination of studies at the University

Users guilty of serious or repeated violation of the regulations will be referred to the Department's Discipline Committee, College Discipline Committee, or University Senate's Discipline Committee.

With the Intellectual Property (Miscellaneous Amendments) Ordinance 2000 put into effect on 1 April 2001, anyone who knowingly possesses an infringing copy of computer software may be criminally liable. ITSC would like to stress the University's policy against using pirated software. Unit heads, department chairpersons, budget holders, and student bodies are responsible for the appropriate management of computer software. They should maintain a proper record of software licenses and proof of purchase of all the software they are using in their department, or student body, conduct periodic software auditing and help disseminate the University's policy to their staff or members.

You, as a staff member or student, should not use computer software that you know or have reason to believe infringes on copyright works. You should also read carefully the terms of the licensing agreements to observe your rights and obligations. You should also refuse and report requests for installation of illegal copies into computers owned by the University.
